Gymnastics and Cheerleading are sports of tumbling skills where the body is placed in the inverted, bridging, forward, backward, and sideways positions. Although landing areas are matted according to USA Gymnastics safety criteria and according to the recommendation of the apparatus manufacturers, falls do occur during the learning process. Any fall from tumbling or an apparatus resulting in improper landing techniques could cause permanent and irreversible damage such as paraplegic, quadriplegic, injuries or even death to your child. Proper landing techniques **are taught** at this gym, but accidents **can still** occur through these sports.
